Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Unfiltered App, and Unfiltered with Kiran and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Unfiltered with Kiran include <https://unfilteredwithkiran.com> and UWK. The UWK application is a News and information, and e-commerce application. By using the UWK application, you consent to the data practices described in this statement. This Privacy Policy is incorporated by reference into the Unfiltered with Kiran, LLC [Terms and Conditions](#).

Collection of your Personal Information

In order to better provide you with products and services offered, UWK may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- Billing Address
- Date of Birth
- E-mail Address
- Phone Number
- Credit Card/Debit Card Information

If you purchase UWK's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Cookies

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer's hard drive.

Our website uses these "cookies" to collection information and to improve our Service. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your computer. If you choose to refuse our cookies, you may not be able to use some portions of our Service.

Use of your Personal Information

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his/her/their right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

How UWK Protects Your Information

Social Media Plug-ins

When you initially visit any of our websites, no Personally Identifiable Information will be transmitted to the provider of the plug in. We give you the opportunity to communicate directly with the provider of the plug in via the corresponding button. By activating the plug in, personal data will be transmitted by you to the respective plug in provider and stored there.
